

DESCRIPTION: Parcel 1

A parcel of land located in the $N\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$ of Section 16, T19N-R1E, Town of Scott, Monroe County, Wisconsin, described as follows: Commencing at the $N\frac{1}{2}$ corner of said Section 16; thence $N86^{\circ}26'19''W$ along the North line of said $NE\frac{1}{4}-NW\frac{1}{4}$ 903.81 feet to the point of beginning; thence continuing $N86^{\circ}26'19''W$ along the North line of said $NE\frac{1}{4}-NW\frac{1}{4}$ 415.00 feet to the NW corner of said $NE\frac{1}{4}-NW\frac{1}{4}$; thence $S0^{\circ}10'49''E$ along the West line of said $NE\frac{1}{4}-NW\frac{1}{4}$ 105.00 feet; thence $S86^{\circ}26'19''E$, 415.00 feet; thence $N0^{\circ}10'49''W$, 105.00 feet to the point of beginning. Said parcel contains 1.00 acre of land, more or less, reserving those lands used for Town Road purposes.

DESCRIPTION: Parcel 2

A parcel of land located in the $N\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$ of Section 16, T19N-R1E, Town of Scott, Monroe County, Wisconsin, described as follows: Beginning at the $N\frac{1}{2}$ corner of said Section 16; thence $N86^{\circ}26'19''W$ along the North line of said $NE\frac{1}{4}-NW\frac{1}{4}$ 903.81 feet; thence $S0^{\circ}10'49''E$, 105.00 feet; thence $N86^{\circ}26'19''W$, 415.00 feet to the West line of said $NE\frac{1}{4}-NW\frac{1}{4}$; thence $S0^{\circ}10'49''E$ along the West line of said $NE\frac{1}{4}-NW\frac{1}{4}$ 224.72 feet to the SW corner of said $N\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$; thence $S86^{\circ}26'10''E$ along the South line of said $N\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$ 1318.91 feet to the SE corner of said $N\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$; thence $N0^{\circ}11'49''W$ 329.79 feet to the point of beginning. Said parcel contains 8.98 acres of land, more or less, reserving those lands used for Town Road purposes.

DESCRIPTION: Parcel 3

The $S\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$ of Section 16, T19N-R1E, Town of Scott, Monroe County, Wisconsin.

Commencing at the $N\frac{1}{2}$ corner of said Section 16; thence $S0^{\circ}11'49''E$ 329.79 feet to the NE corner of said $S\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$ and also being the point of beginning; thence continuing $S0^{\circ}11'49''E$, 329.79 feet to the SE corner of said $S\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$; thence $N86^{\circ}25'59''W$ along the South line of said $S\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$ 1319.01 feet to the SW corner of said $S\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$; thence $N0^{\circ}10'49''W$, 329.72 feet to the NW corner of said $S\frac{1}{2}-N\frac{1}{2}-NE\frac{1}{4}-NW\frac{1}{4}$; thence $S86^{\circ}26'10''E$, 1318.91 feet to the point of beginning. Said parcel contains 9.98 acres of land, more or less, reserving those lands used for Town Road purposes.
