

COMMENCING AT THE NORTH 1/4 CORNER SECTION 9;

GARLAND AVENUE; THENCE ALONG SAID CENTERLINE A
DISTANCE OF 278.87' ALONG THE ARC OF A 300' RADIUS CURVE
CONCAVE TO THE NORTHEAST HAVING A LONG CHORD BEARING
S20°27'52"E, 268.94'; THENCE CONTINUE ALONG SAID
CENTERLINE S47°05'42"E, 282.71'; THENCE S87°22'36"W, 682.88';




